ISO/IEC 20000-1 is a service management system (SMS) standard that specifies requirements for the service provider to plan, establish, implement, operate, monitor, review, maintain and improve an SMS. The requirements include the design, transition, delivery and improvement of services to fulfil agreed service requirements. By passing its **ISO/IEC 20000-1 Upgrade Audit** on Aug. 13, CS has certified to the latest ISO/IEC 20000-1:2018 standard, which saw the revision of two guidance documents in the series and publication of another since the previous 2011 standard.

ISO/IEC 27000 is a family of standards that helps organizations keep information assets secure. Using these standards will help an organization manage the security of assets such as customer data, financial information, intellectual property, employee details or information entrusted by third parties. ISO/IEC 27001 is the best-known standard in the family, providing requirements for an information security management system (ISMS) based on a continuous risk management framework. Passing its **ISO/IEC 27001 Surveillance Audit** on Aug. 13 verifies that CS is continuing to uphold its ISMS requirements.
